

The 2018 DirtFish Rally School Sweepstakes

Official Rules

* NO PURCHASE NECESSARY to enter or win. A purchase does not increase your chance of winning a prize.

Eligibility:

Sweepstakes is open only to legal residents of the Continental U.S., Alaska, and District of Columbia who are 18 years of age or older. Entrants must have a valid U.S. Social Security Number and/or a valid U.S. personal tax identification number. Employees of Subaru of America, Inc. and its parent, DCI Marketing, Inc., affiliates, subsidiaries, advertising and promotion agencies, and their immediate families are not eligible. All federal, state, local, and municipal laws and regulations apply. Void where prohibited.

How to Enter:

Limit one entry per person. Multiple entries received from a person will void all such additional entries.

To enter the sweepstakes via the internet during the Sweepstakes Period (defined below), access The 2018 DirtFish Rally School Sweepstakes website at dp.subaru.com/dirtfish-win, click on the Sweepstakes Entry icon or text link, either of which will take you to The 2018 DirtFish Rally School Sweepstakes Registration Form. Complete and submit the registration form. Information required for The 2018 DirtFish Rally School Sweepstakes Registration Form includes your complete first and last name, address, and email address. Entrant will receive confirmation that entry has been submitted.

Online entries must be received from September 26, 2018, at 12:00 a.m. CST to October 26, 2018, at 11:59 p.m. CST (Sweepstakes Period).
